

## **Resolution to Re-Establish Contact with Inactive Precinct Chairs and Confirm Active Service**

**WHEREAS**, the Denton County Republican Party (DCRP) values the dedication and volunteer service of its Precinct Chairs, who are the foundation of grassroots engagement and community representation

**WHEREAS**, the DCRP has a duty under Texas Election Code §171.029(a) to maintain an active and engaged County Executive Committee, and state law provides for the removal of a precinct chair who fails to perform statutory duties or attend four or more consecutive CEC meetings;

**WHEREAS**, the purpose of this resolution is not to punish or remove volunteers, but rather to confirm the wellbeing and availability of those who have been unreachable or consistently absent, and to ensure that the party is accurately represented and supported in each precinct;

**WHEREAS**, a small number of Precinct Chairs have not attended four or more consecutive CEC meetings and have not communicated with the Chair or Executive Committee during this time, despite multiple outreach efforts;

**WHEREAS**, any individuals identified in this resolution who are present at the current meeting or who respond affirmatively within the timeframe provided shall be removed from the inactive list and welcomed to continue their service without prejudice;

**WHEREAS**, the following Precinct Chairs have missed 3 or more including this current CEC meeting; Precinct 1003, Precinct 1052, Precinct 1061, Precinct 4182, Precinct 4220, Precinct 2108, Precinct 2111, Precinct 3135, Precinct 4181, Precinct 4222, Precinct 4223.

**THEREFORE, BE IT RESOLVED**, that the Denton County Republican Party Chair shall, with the approval of this resolution, send a formal and caring letter via certified mail to each Precinct Chair who has not attended four or more consecutive CEC meetings and has not otherwise communicated with party leadership;

**BE IT FURTHER RESOLVED**, that the letter shall: 1. Express concern for the Chair's wellbeing and appreciation for their service, 2. Inform the Chair that, under Texas Election Code §171.029, failure to respond and affirm a desire to continue serving will result in the seat being declared vacant, 3. Invite the Chair to respond within seven (7) days of receipt to confirm their intent to remain in office or step down voluntarily, 4. Clearly state that this process is being conducted with care and transparency, and not with any intent to shame or embarrass anyone;

**Whereas**, The Denton County Republican Party Executive Committee fully supports the resolution adopted by the Republican Party of Texas (RPT); now therefore, be it Resolved, That the Denton County Republican Party Executive Committee calls upon all elected officials in Denton County and the State of Texas to oppose CAIR's influence and to uphold their oaths to protect the Constitutions of the United States and the State of Texas since failure to counter such an influence constitutes a betrayal of their oaths of office and the public trust; and be it further

**Be it Resolved**, That the Denton County Republican Party Executive Committee urges its members, as well as all Republicans in Denton County, to hold elected officials accountable for ensuring that public policies, ordinances, zoning and other actions affecting the citizens align with the principles of Constitutional liberty, governance, and public safety; and be it further

**Be it Resolved**, That a copy of this resolution be transmitted to the Republican Party of Texas, the Denton County delegation to the Texas Legislature, and all relevant elected officials representing Denton County, as a testament to our commitment to these principles.

# Resolution Opposing Vote Centers in Denton County

**WHEREAS**, vote centers (aka County Wide Polling Places) are a novel approach to voting that allow any registered voter in a county to cast their ballot at any vote center location within the county on Election Day, and

**WHEREAS**, the Denton County Elections Administration has previously showed interest in the implementation of vote centers throughout Denton County and had filed the required initial paperwork in order to implement the change to vote centers, and

**WHEREAS**, the Denton County Republican Party believes that vote centers do not adequately protect the integrity of elections and would create confusion for voters who are accustomed to voting in their traditional neighborhood precincts on Election Day 1, and

**WHEREAS**, the consolidation of and reduction in the number of polling locations in Denton County will increase the time it takes to vote with longer waiting lines and increased drive times, tending to suppress voter turnout and may disenfranchise elderly and disabled voters, and

**WHEREAS**, the Election Administrator stated in a question and answer session hosted by the Denton County Republican Party, that the election software used for the vote center model does not provide voter data by precinct, which the Denton County Republican Party leadership, Precinct Chairs and Republican candidates heavily utilize for get out the vote and campaigning purposes, and

**WHEREAS**, the Denton County Republican Party currently holds a political advantage as the majority party with our candidate for governor historically receiving the highest number of votes in the county, giving our Chairman full selection of the election judges for the primary polling places and a majority of the general election judges, which provides Republican Precinct Chairs more exposure to the voters in their precincts and promoting election integrity, and

**WHEREAS**, voting in neighborhood precincts is a community activity and tradition in Denton County and adds to the many things that makes Denton County a great place to live, setting it apart from neighboring Dallas and Tarrant Counties that have adopted the voting center model, and

**WHEREAS**, aggregating precincts into vote centers combines the results such that auditing and identifying anomalies at the precinct level is no longer possible without technical assistance, and

**WHEREAS**, if voting systems fail at a particular vote center, a greater number of voters are impacted, causing confusion, delays, dissatisfaction and potential disenfranchisement of voters,

**THEREFORE BE IT RESOLVED**, that the Denton County Republican Party opposes the implementation of vote centers in Denton County and directs our Chairman to not

agree to changing to vote centers for any additional elections. We call for the Denton County Elections Administration and the Denton County Commissioners Court to abandon and terminate any plan of installing the vote center model in Denton County and to prioritize the security and community aspect of the voting process over the potential cost savings, convenience, and other administrative reasons behind a decision to change Denton County's voting tradition. Furthermore, we request the Denton County Elections Administrator and the Denton County Commissioners Court be notified of this resolution by providing each Commissioner as well as the County Judge and the Denton County Administrator a copy of this resolution within three (3) business days of passage.
